Subject: Non-Applicability of Corporate Governance Provisions

Ref: Regulation 27(2) and Regulation 15 (2) of Chapter IV of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Sir/ Madam,

In terms of the requirement of Regulation 27(2) of the SEBI (Listing Obligation and Disclosure 2015, the listed entity shall submit quarterly compliance report on Corporate Governance within 21 days from the close of quarter. However, in terms of Regulation 15 (2) of Chapter IV SEBI (Listing and Disclosure Requirements) Regulation, 2015 the Compliance with the Corporate Governance provisions as specified in regulation 27 shall not apply, in respect of:

a) The listed entity having a paid up equity share capital not exceeding Rupees 10 Crores and Net Worth not exceeding Rs. 25 Crores as on the day of the previous financial year.

We hereby inform you that paid up capital and net worth of Sabrimala Industries India Limited as on 31st March, 2022 is Rs. 8,71,45,000 (Rupees Eight Crores Seventy-One Lakhs Forty-Five Thousand Only) and Rs. 6,33,27,000 (Rupees Six Crore Thirty-Three Lakhs Twenty-Seven Thousand Only) respectively, which is under the limits as specified above. Therefore, the company is not required to submit report on corporate governance for the 4th quarter ended on 31st March 2023.

Further whenever this Regulation becomes applicable on the company at a later date, we will comply with the requirements of the same within prescribed time.
